Run order: Utility B &A; Open B &A; ODX B &A, Novice A & B<u>,</u> Beginner Novice

Please remember to include Jump Heights on Open/Utility Entries. Classes will be run in jump height order Junior Obedience Exhibitors be sure to note "JUNIOR" on your entry form! Bitches in heat will NOT be allowed to compete

NOTE TO PERFORMANCE COMPETITORS. All dogs competing for obedience/Rally titles through ASCA® must have a current ASCA registration number or tracking number. If your dog has earned a title through any other registry, but not ASCA®, your dog will be required to begin in Novice.

Tracking Fees for Non-ASCA® Dogs:

All non-ASCA® registered dogs will be required to have an ASCA® Tracking Number. This is a one-time fee of \$15.00 per dog. At the time of applying for the tracking number, the individual owner must also be an ASCA® member (Service member fee-\$10.00). You will be able to apply for a tracking number the day of the show, if your dog does not have one. All dogs entered in performance classes must be at least 6 months of age or older on the day of the show.

ALL exhibitors are required to keep their crating area clean! NO dogs are to be left in the show building unattended.

EXHIBITORS ARE REQUIRED TO CLEAN UP AFTER THEIR DOGS. THERE IS A DESIGNATED POTTY AREA BEHIND THE BUILDING
