Regular Conformation Classes: All Regular Classes, Intact & Altered divided by sex. 6-9 month; 9-12 month; 12-15 month; 15-18 month; Novice; American Bred; Bred By Exhibitor; Open Blue Merle; Open Red Merle; Open Black; Open Red; Best of Breed
Non-Regular Conformation Classes: 2-4 puppy; 4-6 puppy; divided by color and sex. SATURDAY AM shows will also have Veterans 7-9 yrs, Veterans 10-12 yrs, Veterans 13+ (sexes show together), Best Veteran and Michigan Bred class (sexes show together).

Regular Junior Handling Classes: 8-12 Novice Junior; 8-12 Open Junior; 13-17 Novice Senior; 13-17 Open Senior

Non-Regular Classes Junior Handling: Pee Wee 3-5 years; Sub Junior 6-7 years

Judging order for all conformation shows: Altered; Non-Regular; Juniors; Intact.

All PM Conformation shows start 1/2 hour after AM BOB is completed. Entries will re-open during this 1/2 hour break.

Attention All Regular Intact and Altered Class Entries must be at least 6 months of age or older on the day of the show and be ASCA® registered. **YOU WILL BE ASKED TO SHOW PROOF OF YOUR ASCA® REGISTRATION.** No entry shall be accepted from a dog or handler disqualified from the ASCA Conformation program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA

Obedience Trial Class Judging order: Open B, A; ODX B, A; Novice B, A; Beginner Novice B, A; Wildcard
Utility and Open classes will run in jump height order. All trials will be run under the current ASCA rules and regulations. Bitches in heat will NOT be allowed to run. No entry shall be accepted from a dog or handler disqualified from any ASCA programs; or a person not in good standing with ASCA

There will be a 30 minute break between Obedience Trials #1 & #2 on Saturday, and entries will be re-open at that time.

Rally Trial Class Judging Order: Masters C,B,A; Excellent C,B,A; Advanced C,B,A; Novice C,B,A. Team Rally (offered only on Sunday in Trial #1 & #2) Each class will run in jump height order! . All trials will be run under the current ASCA rules and regulations. Bitches in heat will NOT be allowed to run. No entry shall be accepted from a dog or handler disqualified from any ASCA programs; or a person not in good standing with ASCA

Rally classes run in the following order: Masters, Excellent, Advanced, Novice, Team

NOTE TO ALL PERFORMANCE COMPETITORS: THIS IS NOT A MATCH. All dogs will be competing for obedience/rally titles through ASCA®. Each entry form must have a current registration number (ASCA® or recognized registry) and be completely filled out, no exceptions. If your dog has earned a title through any other registry, but not ASCA®, your dog will be required to begin in Novice.

Tracking Fees for Non-ASCA® Dogs: All non-ASCA® registered dogs will be required to have an ASCA® Tracking Number. This is a one-time fee of \$10.00 per dog. At the time of applying for the tracking number, the individual owner must also be an ASCA® member (Service member fee-\$10.00). ASCA® membership does not need to be maintained in subsequent years. You will be able to apply for a tracking number the day of the show, if your dog does not have one. TRACKING NUMBER APPLICATION FORMS ARE AVAILABLE AT: www.asca.org/formsandrulebooks

Payment in full must accompany all entries and be in US funds. The club does not run a tab for entries. **Please make checks payable to "ASC of Michigan". All Pre-entries must be accompanied by a photocopy of each dog's ASCA® Registration.** A \$30 NSF charge will be applied on all return checks. No refunds of entries will be made. ### **GENERAL SHOW AND SITE INFORMATION**

This Show Site will be set up differently this year! **We will NOT be offering the separate grooming building.** Indoor rings will be matted. Outdoor rings will be short cut grass with tenting along one side.

Accessibility for Exhibitors: **The show building will open at 5:00 PM on Friday, September 2, 2016.** There is limited crate/grooming space in this building. **You may be asked to stack crates. PLEASE, NO X Pens.** All dogs and equipment must be removed from the building within ONE HOUR following the conclusion of the show/obedience Trial on Sunday, September 4, 2016

NO CHALKING or BLOWING OUT of CHALK ALLOWED in the building!!! NO GROOMING OR CRATING allowed within 10 feet of the obedience/rally ring. But it will be clearly marked! ALL exhibitors are required to keep their crating area clean! NO dogs are to be left in the show building unattended.

**EXHIBITORS ARE REQUIRED TO CLEAN UP AFTER THEIR DOGS!** All dogs and equipment must be removed from the building within ONE HOUR following the conclusion of the show/obedience Trial on Sunday, September 4, 2016
