ALL ASCA® RULES WILL BE FOLLOWED. NOTE TO ALL PERFORMANCE COMPETITORS: THIS IS NOT A MATCH. All dogs will be competing for obedience/rally titles through ASCA®. Each entry form must have a current registration number (ASCA® or recognized registry) and be completely filled out, no exceptions. If your dog has earned a title through any other registry, but not ASCA®, your dog will be required to begin in Novice.

**Tracking Fees for Non-ASCA® Dogs:** All non-ASCA® registered dogs will be required to have an ASCA® Tracking Number. This is a one-time fee of \$10.00 per dog. At the time of applying for the tracking number, the individual owner must also be an ASCA® member (Service member fee is \$10.00). ASCA® membership does not need to be maintained in subsequent years. ## **GENERAL SHOW AND SITE INFORMATION:**

Show site is indoors; heated/air conditioned with a thick matted floor.

- All crates/grooming tables **MUST** be on a protective mat.
- No x pens allowed.
- There is limited crate/grooming space in this building. **You may be asked to stack crates.**
- There is NO CHALKING or BLOWING OUT of CHALK ALLOWED!!
- There is no GROOMING or CRATING allowed within 10 feet of the obedience/rally ring.
- There will be NO reserving or holding set up space at this facility.
- ALL exhibitors are required to keep their crating area clean! You must leave your area as clean as you found it!
- No dogs are to be left in the show building unattended!
- **EXHIBITORS ARE REQUIRED TO CLEAN UP AFTER THEIR DOGS!!!**

## **ACCESSIBILITY FOR EXHIBITORS:**

- The show building will open at 5:00 pm on Friday, October 21, 2016. If your equipment is inside the building prior to this time, IT WILL BE REMOVED.
- All dogs and equipment must be removed from the building within ONE HOUR following the conclusion of the show/trial on Sunday, October 23, 2016.
