Class order for all Trials: Utility, Open, Novice & Beginner Novice Utility and Open classes will run in jump height order. All Breed Obedience Trial Classes Offered Utility B A; Open B &A; ODX B &A, Novice A & B Please remember to include Jump Heights on Open/Utility Entries. Junior Obedience Exhibitors be sure to note "JUNIOR" on your entry form!

ALL ASCA® RULES WILL BE FOLLOWED

NOTE TO OBEDIENCE COMPETITORS: THIS IS NOT A MATCH. All dogs will be competing for obedience titles through ASCA®. Each entry form must have a current registration number (ASCA® or recognized registry) and be completely filled out, no exceptions. If your dog has earned a title through any other registry, but not ASCA®, your dog will be required to begin in Novice.

Tracking Fees for Non-ASCA® Dogs:

All non-ASCA® registered dogs will be required to have an ASCA® Tracking Number. This is a one-time fee of \$15.00 per dog. At the time of applying for the tracking number, the individual owner must also be an ASCA® member (Service member fee-\$10.00). ASCA® membership does not need to be maintain in subsequent years. You will be able to apply for a tracking number the day of the show, if your dog does not have one. For more information about ASCA®'s conformation and obedience programs and their rules, visit the ASCA® Website: www.asca.org All dogs entered in Obedience Classes must be at least 6 months of age or older on the day of the show and be ASCA® registered; or have (or apply and pay for) an ASCA Tracking Number.

Show Site is indoors; heated/air conditioned with a thick matted floor. REMEMBER NO BLOW DRYERS INSIDE THE BUILDING!

Accessibility for Exhibitors:

The show building will open at 5:00 PM on Friday, April 1, 2016 If your equipment is inside the buildings prior to this time, IT WILL BE RE-MOVED.

There is limited crate/grooming space in this building. You may be asked to stack crates.

NO X Pens Allowed; all crates/groom tables must be on a protective mat NO CHALKING or BLOWING OUT of CHALK ALLOWED!!!

NO GROOMING OR CRATING allowed within 10 feet of the obedience/rally ring

There will be NO reserving or holding set up space at this facility. ALL exhibitors are required to keep their crating area clean! NO dogs are to be left in the show building unattended. EXHIBITORS ARE REQUIRED TO CLEAN UP AFTER THEIR DOGS! THERE IS A DES-IGNATED POTTY AREA NEAR THE BUILDING

Take I-75 to the Bristol Road exit #116. (If you are coming from Ann Arbor US 23 merges with I-75 just south of this exit). Head east on W. Bristol Road. Holiday Drive is about 2 tenths of a mile east of the expressway on your right. There is a traffic light at the intersection and a speedway gas station on the corner. Turn right onto Holiday Drive, it's the second building on the right.
