NOTE TO PERFORMANCE COMPETITORS. All dogs competing for obedience/Rally titles through ASCA® must have a current ASCA registration number or tracking number. If your dog has earned a title through any other registry, but not ASCA®, your dog will be required to begin in Novice.

Tracking Fees for Non-ASCA® Dogs:

All non-ASCA® registered dogs will be required to have an ASCA® Tracking Number. This is a one-time fee of \$15.00 per dog. At the time of applying for the tracking number, the individual owner must also be an ASCA® member (Service member fee-\$10.00). You will be able to apply for a tracking number the day of the show, if your dog does not have one.
