From the West on I-94: Get off at Exit 80 (Sprinkle Rd.). Turn left on Sprinkle and go to 3rd traffic light (BL-94). Turn left and go to 1st road which is Olmstead. Turn right onto Olmstead and continue about 3⁄4 mile to Lake St. Turn left to show site.

From the East on I-94: Get off at Exit 81 (BL-94). Continue on BL-94 across Sprinkle Rd. until you reach Olmstead. Turn right onto Olmstead and continue 3/4 mile to Lake St. Turn left to show site. THERE ARE NEW ROUNDABOUTS AT BOTH EXIT 80 OFF RAMPS
