All Breed Performance Events Entry Information

All entries in Obedience and Rally Classes must be at least 6 months of age or older on the day of the show and be ASCA® registered, or apply and pay for an ASCA Tracking Number. You may be asked to show proof of registration. **No Bitches In Season.**

****No entry shall be accepted from a dog or handler disqualified from any ASCA program; or a person not in good standing with ASCA. Please remember to include Jump Heights on Open/Utility entries and Rally entries. Junior Obedience Exhibitors be sure to note "JUNIOR" on your entry form!**

Judging order for all Obedience Trials: Utility, Open, Novice & Grad Novice, Beginner Novice. Utility and Open classes will run in jump height order. Novice group exercises will follow individual exercises. **Obed Trials are Limited to 20 Entries per Trial** (waiting list after limit is reached). Trial is under cover on dirt. Great practice for Nationals in TX.

Obedience Classes offered: Utility A/B; Open CDX/B; Open ODX A/B; Novice A/B/C; Grad Novice A/B; Beg Nov A/B

Judging order for all Rally Trials: Masters, Excellent, Advanced, Novice. Classes will be run in jump height order. *Please remember to include your Jump Heights!* **All Rally Trials are Limited to 35 Entries per Trial** (waiting list after limit is reached) Great practice for Nationals in TX.

All Breed Rally Trial Classes Offered: Masters A/B/C; Excellent A/B/C; Advanced A/B/C; Novice A/B/C

ALL ASCA® RULES WILL BE FOLLOWED

NOTE TO PERFORMANCE COMPETITORS: THIS IS NOT A MATCH. All dogs will be competing for obedience titles through ASCA®. Each entry form must have a current registration number (ASCA® or recognized registry) and be completely filled out, no exceptions. If your dog has earned a title through any other registry, but not ASCA®, your dog will be required to begin in Novice. Tracking Fees for Non-ASCA® Dogs: All non-ASCA® registered dogs will be required to have an ASCA® Tracking Number. This is a one-time fee of \$20.00 per dog. At the time of applying for the tracking number, the individual owner must also be an ASCA® member (Service member fee-\$20.00). ASCA® membership does not need to be maintained in subsequent years. You will be able to apply for a tracking number the day of the show, if your dog does not have one.
