NOTE TO OBEDIENCE COMPETITORS: THIS IS NOT A MATCH. All dogs will be competing for obedience titles through ASCA®. Each entry form must have a current registration number (ASCA® or recognized registry) and be completely filled out, no exceptions. If your dog has earned a obedience title through any other registry, but not ASCA®, your dog will be required to begin in Novice B. Tracking Fees for Non-ASCA® Dogs: All non-ASCA® registered dogs will be required to have an ASCA® Tracking Number. This is a one-time fee of \$10.00 per dog. At the time of applying for the tracking number, the individual owner must also be an ASCA® member (Service member fee-\$10.00). ASCA® membership does not need to be maintain in subsequent years. You will be able to apply for a tracking number the day of the show, if your dog does not have one. Conformation rings will be gaited and matted; Obedience and Rally are in a separate building from Conformation and the ring is 40X50 and fully matted.

Center ends of buildings may be open or closed depending on weather.
