All entries in the Performance Classes must be at least 6 months of age or older on the day of the show and be ASCA® registered, or apply and pay for an ASCA Tracking Number. You may be asked to show proof of registration. **No Bitches In Season in Rally & Obedience**

***No entry shall be accepted from a dog or handler disqualified from any ASCA program; or a person not in good standing with ASCA. Please remember to include Jump Heights on Open/Utility entries and Rally entries. Junior Obedience Exhibitors be sure to note "JUNIOR" on your entry form!*

Bitches in Season may run in Scent Detection. They must be kenneled and pottied in an area away from others, wear pants and run last, and the competitor should contact the Trial host seventy-two hours in advance if they anticipate their dog will be in season

****Judging order for all Obedience Trials: Utility, Open, Novice & Grad Novice, Beginner Novice.** Utility and Open classes will run in jump height order. Novice group exercises will follow individual exercises. **Obed Trials are Limited to 20 Entries per Trial** (waiting list after limit is reached). Trial is under cover on dirt.

ALL ASCA® RULES WILL BE FOLLOWED

NOTE TO PERFORMANCE COMPETITORS: THIS IS NOT A MATCH. All dogs will be competing for obedience titles through ASCA®. Each entry form must have a current registration number (ASCA® or recognized registry) and be completely filled out, no exceptions. If your dog has earned a title through any other registry, but not ASCA®, your dog will be required to begin in Novice. Tracking Fees for Non-ASCA® Dogs: All non-ASCA® registered dogs will be required to have an ASCA® Tracking Number if you wish to earn ASCA titles. This is a one-time fee of \$20.00 per dog. At the time of applying for the tracking number, the individual owner must also be an ASCA® member (Service member fee-\$20.00). ASCA® membership does not need to be maintained in subsequent years. You will be able to apply for a tracking number the day of the show, if your dog does not have one.
